P/C Resilience

Increasingly lower. Energy depletion on all levels, exhaustion, anxiety, hopelessness, frustration, feelings of disempowerment, very poor sleep levels, unable to access services, or in a timely manner, or to access the items they need.

P/C Isolation

Many families do not have family support close by, or any support adding to feelings of isolation plus families not understanding their lived experience)

Feeling isolated - difficulty in accessing technology to connect, transport issues and availability to meet others.

(Especially home Ed / EHE / AP etc)

P/C Stress and Exhaustion

Parents high level of stress, exhaustion etc being marginalised, sidelined, ignored, - it seems maybe a decline in a human approach first and foremost.

P/C Grief

Parental grief ... lack of support over major life changes, eg. diagnosis, work and financial implications, relationship breakdown, including with their CYP.

PB Payments

Problems accessing PB payments -

being flatly denied when they should be available -

no support to help achieve better outcomes.

Access to equipment

Difficulties accessing necessary equipment and home adjustments.

Difficulty accessing hoists etc as children getting bigger, wheelchairs etc.

P/C's worries for future

Worry of P/c's for the future of their YP, especially suitable accommodation, training/ work opportunities and suitable support going forwards, especially as many p/c's realise as their children hit secondary school, the gaps with their peers increased, and if services are as poor as they are at this stage what will be there for their CYP and them going forwards- this is popping up increasingly. Many concerned the lack of awareness and understanding amongst some professionals, and in society. "...... I am really concerned for my son's future, he is being treated for his age, not his development, (approx. age 3) a tick box exercise for travel training, he has no idea. He can do something with guidance, tick the box, ask him tomorrow, he can't do"
