FVP Parent Representatives

Introduction

As with all previous PCC grant reporting in line with the reporting format introduced in the last financial year, to match annual reporting requirements this report will be set out in sections that match predicted outcomes. The report will also have a final statement detailing potential recommendations and ways forward. The only difference for this financial year is that this report will no longer contain a section on work relating specifically to health funding. Previously PCC and Health funds were combined which is no longer the case. The report will be set out under the following headings:

- Wellbeing.
- SEND Data and Schools Work
- Seldom Heard Communities
- Co-production and Change

There is some crossover between areas, with work often having the potential to fall in more than one section. The ongoing impact of the cost of living crisis, the separation between Peterborough and Cambridgeshire shared services and other local and national concerns have an effect on Family Voice Peterborough (FVP) and the work of the Parent Carer Forum (PCF) as well as the beneficiaries to the wider charity primarily Parent Carers. This reporting period has been quite busy with respect of general parent participation and wider support.

Work has moved consistently back to face to face methods with some online participation via survey completion. This has also been possible through grant funding from Peterborough City Council, Cambridgeshire and Peterborough Integrated Care System, The Department for Education (DfE) and The National Lottery (tNL) amongst other funding sources.

Over the past three months (April 1st to June 31st) FVP have seen engagement from 6 Fathers, 55 Mothers, who are new to FVP, on an individual basis where details are known whose ethnicity ranges from White British to Pakistani British, African and/ or Central & Eastern European. Further participation has occurred across a range of areas through completion of surveys to attendance at a variety of face to face activities. Wider engagement across 20 opportunities enabled 308 people to get involved at some level.

Participation/Engagement/Involvement April – June 2023

Headlines

- 1) 133 named parents in total have been involved at some level.
- 2) 30 parent carers have participated across 1 online survey.
- 3) Children's/ Young people disabilities/ needs have been reported by parents as including (This list is not exhaustive):
 - a) Autism Spectrum Disorder
 - b) Attention Deficit and Hyperactivity Disorder
 - c) On the Neurodevelopmental Diagnostic Pathway
 - d) Varying degrees of Learning Disabilities and Difficulties
 - e) Global Developmental Delay
 - f) Genetic Disorders
 - g) Downs Syndrome
 - h) Cerebral Palsy
 - i) Spina Bifida
 - j) Achondroplasia
 - k) Social, Emotional and Mental Health Needs, including Eating Disorders and Anxiety Disorders.
- 4) 6 new fathers have been involved.
- 5) Parent carers reported the ages of their children/ young people as between 2 to 25.
- 6) Participation methods used included; online surveys, case studies, face to face activities, one-to-one telephone or email engagement and parent representation.
- 7) Evidence is both qualitative and quantitative in nature.
- 8) Ethnicity data will be referenced in the full report, we have moved toward categorizing in line with census categories.

Wellbeing

Introduction

Some of this work is funded via more than one source especially where the grants have similar outcomes. The funding split can include one grant covering the cost of items for example and another grant covering the cost of staffing and volunteers to administer the work. This means some information may appear in more than one monitoring report.

Joint funded work streams relating to areas such as food support and access to signposting has been included here due to their overall impact on mental wellbeing.

Food Support

Food support continues to be an identified need, especially in relation to access to healthier food choices such as fruit and vegetables.

Support has been provided to 2 known households as well as attendees at the FVP café and food hub. Of those known:

Both households report having low income levels, and stuggling to manage in particular with school holiday periods.



Kerry, who volunteers at FVP after asking for help for herself and her son, said: "Even the cheapest food is going up a lot so coming here is really helpful. "I'm helping by giving other people the courage to come and to talk, and to collect food as well."

Signposting/ Support Requests

The needs of those requesting signposting and support have changed and it appears more than signposting is required, especially due to a change in the complexity of signposting support requests. Families are seeking support across a broader range of areas, and these are related to much more than education.

There have been 38 contacts recorded where parent carers new to FVP have requested signposting. Where direct signposting requests have been received it is known that 30 would be considered 'White British' and one has self-identified as a father. The number of parent carers requesting signposting from seldom heard communities in relation to ethnicity is lower this quarter but this is already changing as this report is being written and in the next quarter figures will be different.

From these and other contacts with parent carers the team of parent representatives at FVP have identified the following themes:

Health, MH and Education

- 1. Parents difficulty accessing MH, services for their children either via GP or support from school
- 2. (..... even threatening a parent with fines as failing to recognise anxiety (maybe be burnout) GP refusing to refer to CAMHS, school will only recognise if CAMHS involved, GP refuses to help.)
- 3. Focus on suspensions/ exclusions by schools, sometimes many in a day and 'punishment' for responses in line with their disability. A push by schools to permanently exclude more challenging children, even sending parents info for other schools (!)
- 4. No notice to parents for reducing timetables, including pre school provision.
- 5. Schools not taking into account child's wishes (they love their school, friends, etc) and not working with the child where the child is at.
- 6. Schools fobbing off parents by not doing the things they should be doing, hoping parents do not know any better. Adding to parent's tensions, then as always parent's blamed for complaining.
- 7. Lack of resilience/ tiredness in parents newly diagnosed children, needing breaks, help with understanding their children, how to adapt and needing more support/advice.
- 8. Some pre-schools/ nurseries much better than others- more training needed at a younger level.
- 9. Lack of special school places, parents willing to try new provisions being proposed, but if they don't work preferring special school options.

Lessening resilience of children/ teenagers with other needs, worsening MH, lack of support schools/ GP's, self harm and not addressing stress when there is previous history.

- 1. Lack of understanding/ empathy by GP's of what Autism and MH is (sorry to put in same sentence but this is coming up a lot at mo), and how this is severely impacting children and their families. Lack of diagnoses and a reluctance by GP's to refer to various places, assessments etc adding to the issues.
- 2. Difficulties accessing Sendiass (Aware of new changes to team which should help going forwards)

Food Support

1. mainly for more specialised foods that they cannot access because of cost of living crisis.

Housing and Homelessness

- 1. Threats of evictions as rents being out up, it is very difficult for any parent in that position with children with additional needs having the uncertainty of so many variables adding to already tense situations. Working parents too, struggling on top of the challenges they already have.
- 2. Families with children disabilities, especially ASD/ ADHD, etc needing own bedrooms

Single Parents

1. Feeling lonely and isolated, across cultures.

Activities for disabled children and families

- 1. Very much called for, especially for 'no judgement'
- 2. Parents diagnosed/ identifying as ASD, starting to see this come through more ... that there challenges are being ignored by various services (eg schools, education, health that maybe involved.)

DLA-PIP

1. Parents often worried for this transition, seems daunting, needing support to do these.

Parent's Resilience

 Lack of breaks, constant tiredness, pushbacks from school and health services, lack of resources

From feedback gathered in relation to the signposting being offered it is clear the service is appreciated. Examples of responses received to the questions; What difference has your contact with FVP made to you? And What did you do after your contact with Family Voice for example feel confident to contact organisations when you require?:

Knowing where to go for support

Family voice has given me support, good advice and also sign posted me to get further support, also been to events with my children which are lovely so can meet up with other families and carers so can then give each other support

Someone understanding, something to try, (initial suggestion worked but then passed back to originating issue ...(following today's call more suggestions to try)

Felt more confident to speak to other people for help , for example sen at school

Continued with the course of action I had already put in motion

Although some of this work is directly funded via a range of sources, the staffing in relation to administration through to delivery is funded via PCC, Lottery and ICB funding. Most surveys will have a micro report detailing basic findings and recommendations. The transport strategy feedback survey is available to view via the survey page of FVPs website. Overall findings from the survey were:

Overall, the strategy was viewed positively with respondents showing that the proposed changes would make a difference to their families. There are still some concerns reflected in the wider comments, which would match with the other data gathered in previous surveys. These relate to communication, responding to concerns/complains appropriately and transport provider training, especially in relation to neurodiversity. The underlying issues need to be resolved so that the children with SEND as well as their families can have a more positive experience.

There is some scepticism amongst the respondents whether the proposed changes will be carried through, which is concerning. This may be because either parent carers have had a previous bad experience with the service or due to wider issues with SEND services overall.

Your Say Forms

A form called 'Your Say' is used to gather more general anonymised feedback regards services relating to Education, Health and Social Care. These forms have predominantly been completed by parents who self-describe as Pakistani British. They have children with range of complex needs and physical disabilities.

Feedback on services is mixed but three main areas that standout are:

- 1. Health services are stretched and waiting times are too long
- 2. Funding for schools impacts on provision
- 3. Overall the feedback is more positive, despite issues and concerns.

Strategic attendance

Through the ongoing use of the online form used for parent representatives to report on strategic meetings attended, it has been easier to demonstrate time invested and work/actions as a result of the meetings attended

FVP have a total of 5 parent carers employed as parent reps and they share meeting attendance with the Forum Coordinator, CEO and Participation Project Officer.

General themes from Schools engagement

- Lack of Family Voice awareness from school staff and some SENCos.
- Awareness of the support available with SEN reports, signposting, building the bridge between parent carers and professionals.
- Awareness of parent support that Family Voice offers through trips, signposting, parent carer hub sessions and training.
- Lack of awareness of how engagement with parent carers can help them to improve the services and, in turn, outcomes for their children and young people.

Barriers

There have been certain barriers that we had to overcome in order to improve the engagement with SENCOs. Because school office staff were unaware of FVP they were not always passing the information (meaning our leaflets) to the relevant people and can be very reluctant to share the information (e.g., who the SENCo is). This has proven to be the main barrier to engage with schools, however it became apparent that the more face-to-face contact we have, it then changes people's perspective. This led to changing the way Parent Reps engage with schools in order to improve the outcomes.

Outcomes/ Difference

All Saint's primary school – case study

Family Voice Representatives had 2 coffee mornings at All Saint's school with another 4 dotted throughout the next Academic Year. The demographics of this schools is very diverse, with a lot of families classed as Seldom Heard – this provided us with an excellent opportunity to engage with them as they may not have gone to an event in a different setting. Although the setting is very welcoming to their parent carers, due to the language and other barriers, they struggle to engage with some of them. The SENCo also felt that a lot of them could benefit from some external services, however she was unsure of what other help was available to the parent carers and how to access it.

It is important to note, that some of the Seldom Heard parents, albeit a little disconnected at first, have found our coffee mornings very useful and continued to engage with FVP during the next coffee morning. The increase in confidence means that they will not only feel less isolated, but will be able to join FVP at other activities, access the help they need through other services, which, in turn, will improve outcomes for their children and families and them a voice that could help shape current and future services.

Narrative on issues/ themes mentioned

- Little knowledge of NHS funded nappies/pull ups for children with SEND as parents are currently paying for them. All Saints have made 3 referrals since our first meeting. This will help parent carers access the right size nappies/pull-ups and will alleviate some of their financial burned that comes with sourcing their own nappies.
- Parents struggling with sleep patterns for their children and are unaware of any help available to them
- Parents with worries about the SALT services available to those children who are currently awaiting diagnoses.
- In order for parent carers to feel less isolated and more informed, FVP has shared a copy of SEND newsletter which gives information on groups, activities, trips and support over the summer holidays

What difference FVP coffee mornings made to schools (Feedback from SENCOs):

Working with Family Voice has been very important for our school over the last academic year. It has provided opportunities for parents to know there is a network of people they can talk to and ask questions to; we have learnt lots as a school community about the resources

and services that are just at our doorstep. Online courses have also increased the confidence of parents. I look forward to working with them more in the future!

Giving the parents a contact and highlighting that they can access support for their children. The parents gave very positive feedback to school staff about the session. Thank you very much.

Creating a space for parents to meet others, share worries, questions, being aware of specialist services having someone to answer questions SENCO/school cannot.

As you can see from the feedback above, SENCOs value our input and they feel we make a difference to their parent carers. SENCOs have highlighted how difficult it is to know the information that parent carers so desperately need, whether it is about what their children and their families are entitled to, where do go and seek help and support when the need arises, or what are other services available to them (e.g. carer's assessments, nappies, day opportunities for their children, family breaks etc). This information can sometimes be hard to find and as SENCOs feel already overwhelmed with their busy roles, they welcome us to their schools to provide the necessary information and help their parent carers.

What difference FVP coffee mornings made to Parent Carers (Parents verbal feedback):

My English is not very good, and I worry people don't understand me and that's why I don't speak a lot. Thank you for making me feel better about it, being patient and listening to me. I will speak with SENDIASS and use the DLA guide you told me about. If I need more information, I know who to call. Thank you for that.

I didn't know that there were other services available for my child, like short breaks, direct payments and many other organisations that can provide my child with some other activities during the weekends and school holidays. I didn't even know that the 0-25 Disability Team existed! My head is buzzing with all the new information you have given to us.

As can be seen from the information above, parent carers are not always aware about the services available to their children and families. They often feel 'stuck' in their own world and feel as if no one cares about them. They feel very empowered when finding out the information about different services and always tell us they wish they knew about it sooner. Parent carers feel more empowered to seek the help they need; they have better knowledge about their entitlement and feel relieved that the services they thought do not exist are actually available to them.

Lime Orton Academy - Afternoon Tea Report

There were 8 parents present. Most were busy catching up with each other.

I asked the family liaison for any issues that may have been noticing more than others, with the details below being provided:

Support

Families not getting the support they need,- Social Services, especially respite is very challenging to achieve.

Services

Across the board services are full to capacity

Direct Payments

Families need someone who can do the work that they can entrust their children to.

Biggest stand out, Transition and support around transition for their students, LA having final say where their students will go.

Positive story For the first time ever, this year one of their students has been accepted for 'SENSE', normally a real challenge.

Lime Academy has a new parent group called 'Parent Voice', feeding back to the school re. their experiences.. I have asked if they have anything coming through as in any themes that they could share with us re. any general issues that would be worth knowing.asked me about what we do at FVP. I shared the various roles FVP has locally and providing parent's views for feeding into decision making by LA.

General Feedback from a family worker with a local charity

She is noticing lots of issues with children reception/ Yr 1 who are way behind their normal development. Teachers saying it's like they are doing the work of nursery and pre-schools, lack of communication skills, toileting issues, etc, things normally seen with younger children, impacts of Covid.

Seeing 4 year olds learning from 2 year old.

Classes being split into 3 to give more attention, however needs more staff, TA's and premises. Educating staff.

YR6 SEMH issues, usual things that occur like body development have not been around each other and missed in that development.

Example of son, age 15, really stressed, normal development environment in peer group missed.

Staff need educating for better understanding.

...... Family support worker

Would like to connect with, Peterborough Muslim Women's SEND group. Punjabi community, cannot access translation on PCC website as many are illiterate.

Positive Feedback

..... parent, daughter 5 ½ yrs, complex needs. Had lots of praise for the services involved, including disability social worker, neuro disability team, hospice- support call and breaks .Her wellbeing team at her GP surgery are good, 'they make all the difference' they call her and arrange a check in every 6 weeks, offer of a phone call or visit... she did add that she often feels guilty as she knows other parents don't have this level of support.

Attendance at coffee meetings and themed sessions has been low, but they are well received and have resulted in parents following up with signposting requests.

The Census data for Peterborough shows a population range of approximately 60% White British to 40% Other Ethnic Backgrounds (combined).

New Peterborough Faith Based Womens SEND Group (not Aiming High Group)

I was made very welcome, baked a lovely cake, and they helped me with parking.

Number of parents 5 including &

Caring together had been invited but couldn't attend this session.

Discussions

From the outset the ladies clearly shared a sincere love of their faith, shared respect, and how important it is in their family lives- this was a natural part of the conversation, rather than educating me... how important the Quoran is to them, and shared a story how a young ASD boy was able to recite the Quoran despite his many difficulties/ SEN needs, they felt that was amazing.

The ladies group explained how difficult it can be to come together and discuss disability issues as often it's taboo within families and friends. They are a mixed cultural group, and a couple have converted to Islam. One lady was recently bereaved and was just about holding things together for her children.

Group Lead Themes

- 1. I mentioned The Aiming High Group to She would like to have their group shared by Aiming high
- 2. had applied for a job with a charity, citing flexible working hours, when it came to the interview, that had changed somewhat. She has no family support. She felt as if she may be being discriminated against as it simply wasn't possible to do the hours

stated. She has 15 yrs experience and this was a basic admin role. They offered her a volunteer position.

Children's Issues/ Challenges and Signposting

- 1., 3 children, aged between 7 and 17. Youngest complex needs, Spina Bifida, ASD, hydrocephalus (?) Marfan syndrome, food issues, suddenly stopped all food including things they like; 11 yr old, suspected ASD, anxious about school and going to secondary- Hampton College- I suggested contacting Senco for a chat ahead of the school year to talk through concerns and raise the possibility of ASD..
- 2. concerns Autism and puberty in the future, possible PDA. Suggested PDA website for info and strategies. (When PDA was mentioned a few parents raised that as a possibility with their children)
- 3.has 5 children/ young people aged between 25 and 4. Four girls and one boy. One daughter has Epilepsy. Son has Microcephaly and is non-verbal with global development delay, mental age 12-18 months. Genetic, skips generations, possibly toxin/ Zika virus although feels more genetic. Family also experiencing grief due to close family bereavement. would like to find other parents/ carers locally with children with microcephaly.
- 4._son is 14, at Kings School. He is hyperactive. School put her son into isolation, no support. Global delay with ASD traits. Wanting to move schools, has spoken with Jack Hunt, I suggested contacting Sendiass. Son wants to move schools, very unhappy at Kings. Would like info on holiday activities, he likes archery.
- 5., child Yr 1, ASD. She was previously a TA, 17 yrs, Queen Katherine, left as no allowance to fit in with childcare. Annual Review, March, all ok in mainstream, was non- verbal, now communicating, now learning Quoran. Asked me about home educating, EHE and EOTAS,PB's, signposted to Fb groups to find out more and to come back to us if any more info.

General Concerns Arising from Meeting

- 1. More info EHCP's The group would like a talk specifically about EHCP's
- 2. Kings School not catering for ethnicity, disability/ SEN (..... shared that a child/ family she knows is having a good experience)
- 3. Concerns across the group re. Autism and puberty- a lot of fears and worries, (I shared that everything isn't necessarily bad or negative though it's a good idea to prepare for puberty with their children as can occur early in children ASD)
- 4. Much concern across group re. sex education in schools, unhappy with sex education too much, too soon, for children- too young. Feeling lack of balance in this area of children's education.
- 5. PDA mentioned by 3 parents and frustration Peterborough not diagnosing- More help needed for parents to manage challenges, challenging behaviour, and their own wellbeing. I directed to PDA society website/ Fb group... info re PDA- clearer to see if that is their child or not plus lots of info and strategies that may help either way.
- 6. Autism Diagnosis- then what? Lack of support and info eg a young girl age 7, no support service A talk/ meeting could be helpful. I said that for younger children there is a more joined up approach for the early years children.

<u>Actions</u>

- 1. Signposting relevant parent enquiries from meeting
- 2. For FVP to attend the next meeting.

AHG Bowling Session

Themes	Details	Outcomes
Little to no knowledge about short breaks and other activities for children with SEND, especially during the school holidays. 2 families needed some help from SENDIASS and they were very happy to have them present on the day as they find the face-to-face engagement far easier and do not feel very comfortable speaking on the phone/emailing. One particular family, with very limited English, were unaware that their son was on an illegal part time table. Their child is attending a special school 1 hour a day, which starts after the other children leave the school. Information was given to parent carers about available offers, however they were extremely cautious when social services were mentioned, thinking that the only reason for the involvement from the services if the child's needs are not being met at home or there is a safeguarding issue	30 parent carers attended and the team has spoken to every parent carer. Other work as detailed in this report has taken place to include community leaders as well as parent carers from seldom heard communities together, by way of community based trips, activities and events such as a community barbeque that took place in May.

Current Themes/ Parent Carer Concerns

The current themes being raised by parent carers and the parent rep team include:

- 1. Transport concerns will the strategy really make a difference?
- 2. Lack of funding leading to poor education SEND children not welcome in settings.
- 3. Increased waiting times to access health care.
- 4. Parent carers still feeling there is not enough information for them and their CYP in relation to SEND.
- 5. Decreased parent carer resilience; pare carers reporting being tired, stressed and overwhelmed much of the time.
- 6. Stresses on households relating to financial pressures due to the ongoing cost of living concerns.
- 7. Positive experiences do occur, but there is often the view that it is a fight to get to that point.

These themes can be identified via signposting contact, completion of surveys and feedback forms and conversations with parents at a range of activities and events.

Co-production and Change

Topics of Importance

There have not been any Topics of Importance (ToI) yet. Two responses have now been received from the last quarter of the last financial year (PfA and Resilience) which can now be downloaded from FVP website.

Coproduction

Some coproduction has occurred in relation to development of the transport strategy, work relating to the Accelerated Progress Plan and a variety of documents relating to Preparing for Adulthood.

What is the difference?

We have seen increased take up and positive feedback from the schools offer work, with 10 schools signed up so far. One SENCO said about what difference the offer makes:

"Creating a space for parents to meet others, share worries, questions, being aware of specialist services having someone to answer questions SENCO/school cannot."

When asked what difference the trips and sign posting had made to families two responded with:

"more confident to speak to other people for help, for example sen at school"

"The day made a difference in the sense that she spent the rest of the day outside and learning to wait in queue."

Parents and settings report differences on individual levels relating increased awareness of support, confidence in managing situations and changes in the behaviour of their CYP as result of all FVP have on offer.

Recommendations/ Forward Plans

- 1. Complete a Tol relating to educational experience and health waiting times
- 2. Work continues to engage with a wider more diverse section of the parent carer community locally.
- 3. To work with PCC and Health Partners to explore solutions to themes raised through parent carer concerns
- 4. To explore better ways of establishing outcomes and impact from the work of FVP.
